## RELIGIOUS EDUCATION

Faith formation classes for children of the parish (1<sup>st</sup> to 8<sup>th</sup> grade) are offered through our Religious Education program. St. Mary's follows the curriculum for religious education developed by the Archdiocese of Chicago. We benefit from a wonderful team of dedicated catechists willing to share their faith with the children. The 2017-2018 year was successful because of the terrific support from families, volunteers, and catechists.

### 336 Students | 238 Families | 27 Catechists | 6 Student Aides

- The Sacrament of Confirmation has been celebrated as a parish with School of St. Mary and Religious Ed students being confirmed together for many years. This past year, First Communion was also celebrated as a parish with school students, RE students and other private schools celebrating the First Eucharist together.
- Students learn faith concepts, prayers, Scripture, and works of mercy. Lessons include variety of activities including Scripture, Catholic art, illustrations, vocabulary, and prayers.
- St. Mary's Religious Education program supports parents as the first educators of the Faith. Family catechesis was
  provided through sacramental preparation meetings, Reconciliation and First Communion retreats for parents and
  children, as well as 7<sup>th</sup> grade Service meeting, and 8<sup>th</sup> grade Confirmation meeting for parents, sponsors, and students.
- Parents were also invited to participate in prayer services, Open Houses, and special events.

#### CHILDREN'S LITURGY OF THE WORD

- Throughout the school year, St. Mary's offers Children's Liturgy of the Word on Sundays for all children of the parish age 4 through 5<sup>th</sup> grade.
- Children's Liturgy of the Word is offered at the 10:00am Mass on Sunday.
- Trained catechists lead these sessions to help our young ones understand and relate to the Sunday Scriptures.

#### **VACATION BIBLE SCHOOL**

During the summer, children ages 4 to 10 participated in a fun-filled week of Vacation Bible School. The theme this year focused on vocations. Children learned about the vocations of priesthood, religious life, and Matrimony.

# INCOME STATEMENT FINANCIAL FOOTNOTES

#### THE ARCHDIOCESE OF CHICAGO & PARISH OF ST. MARY ACCOUNTING POLICIES

The Parish of St. Mary's financial statements are prepared on the modified cash basis, which is a comprehensive basis other than generally accepted accounting principles in the United States of America (US GAAP). Under the modified cash basis of accounting, adjustments to the cash basis accounts are made to conform to certain Archdiocesan provisions. Revenues and expenses are recognized only as cash received or paid, except as for certain modifications specified by the Archdiocese. Prepaid tuition is recognized as a liability in the statements of financial position - modified cash basis, and the Parish endowment funds are recorded at fair value as provided by the Archdiocese. In addition, the Archdiocesan provisions require real property of the Parish to be held in trust by the Archdiocese of Chicago. Other land and buildings, such as rental properties and the Primary Grade Center land, are carried at cost by the Parish and are not depreciated.

**{1} - Investments & Endowment Funds**The Parish of St. Mary holds two endowment fund assets, each with a permanently restricted corpus and both held in charter with the Archdiocesan Bank. The Parish Educational Endowment Fund is restricted for educational use only by the Parish. The Parish can draw from the balance of temporarily restricted realized gains at any point in time to support the further education of children and adults alike through the Religious Education program, Evangelization or the School. Changes in the balances are from pooled Investment gains or losses and donations received by the Church and deposited into the fund.

The Parish Scholarship Endowment Fund corpus was donated from an anonymous donor in 2007 for the purpose of supporting families with financial need in attending the School of St. Mary. Per the charter, only 5% of temporarily restricted realized gains can be withdrawn annually.

#### {5} - School of St. Mary Tuition & Financial Aid

- \$48,350 was received as tuition subsidy from St. Patrick's Church for children that were parishioners of St. Patrick's who attended the School of St. Mary in FY2018.
- \$3,720 of uncollected tuition from prior years was collected and recorded in income in the current year. All but \$4,730 of current year tuition was collected in FY2018.
- The Parish awarded \$62,440 in need-based financial aid in FY2018 to 19 families with 24 children.

#### {6} - School of St. Mary Parents' Association Donations

A total of \$445,865 was donated by the School of St. Mary Parents' Association in FY2018 to the School of St. Mary and was designated for the following purposes:

• \$210,000 was donated to support School Operating Expenses

- (Fundraising Net Income)
- \$80,000 was donated for School Staff Financial Gifts (Temporarily Restricted)
- \$40,000 was donated for Academic Year 2017-2018 Financial Aid for need based families (Tuition, Registration & Comprehensive Fees)
- \$115,865 was donated from Parents' Association Prior Years' Surplus and was released for the restricted use of:
- Primary & Upper Grade Center Epson Interactive Projectors
- School Staff Laptops School Staff Polo Shirts

#### {7}- Parish School Investment

FY2018 Parish Investment of the School totaled \$793,955 of which includes budgeted investment, capital improvements and operating shortfall. The FY2018 Parish Investment to the Religious Education program totaled \$83,897 of which included budgeted investment and operating shortfall.

#### {8} - Archdiocesan Assessments

The Parish of St. Mary pays four assessments to the Chicago Archdiocese annually:

#### Archdiocese Assessment

The Archdiocese Assessment is billed at 10% of the Church's ordinary income (less interest) from FY2016 reported closed financials. This assessment positively impacts the Parish of St. Mary with supporting functions such as: financial, operational, legal, insurance, risk management, human resources, payroll, employee benefits, religious education as well as pastoral and liturgical

#### Office of Catholic Schools Assessment (OCS)

The Office of Catholic Schools Assessment (OCS) is billed at a rate per student. The cost per student in FY2018 was \$25.00. The Office of Catholic Schools helps to support the School of St. Mary with services concerning human resources, legal, instructional and educational needs.

#### Lease & License Assessment

The Archdiocese Lease & License Assessment is billed at 10% of lease ordinary income received by the Parish from residential home rental leases and room leases.

Priest Retirement Mutual Aid Association Assessment (PRMAA) The PRMAA Assessment supports the retirement fund for our priests within the Chicago Archdiocese. The amount billed by PRMAA is

3.5% of the total church operating revenue (less interest) of FY2017 reported closed financials.




#### Generosity of Our Parish \$3,195,149 Donated Within our Parish and Universal Church
