



Dear Parishioners,

With gratitude flowing from my heart I write to you as your pastor, very glad that this annual report is in your hands, communicating the generosity of the parishioners, and the ministry served faithfully by many caring hands at the Church of St. Mary from July 1st, 2022 – June 30th, 2023.

The Parish Finance Council has chosen the theme of "We are the body of Christ" to summarize and capture the truths and the hopes we share and live at St. Mary's.

In reading the New Testament, in 1 Corinthians: 12:12 we read and pray:

"AS A BODY IS ONE THOUGH IT HAS MANY PARTS,

and all the parts of the body,

THOUGH MANY, ARE ONE BODY, SO ALSO CHRIST."

When we come together to worship, we lift our voices in sung prayer. Hymn #590 in our Music Issue of Today's Missal has both Spanish and English lyrics of this beautiful hymn. The English words are:

## We Are The Body of Christ

Dear Fellow Parishioners,

The Parish Finance Council is pleased to present the Annual Financial Report for the period ending June 30, 2023. The Church of St. Mary enjoyed another strong year financially. It is the Council's pleasure to provide Father Nacius with advice on the parish's financial affairs so that he and his staff can focus on spreading the Good News of Christ's resurrection. With the resources generously contributed by our faithful community, the Church of St. Mary was able to support a multitude of good works that enriched and strengthened our parish community. Thanks to the abundance of our blessings, the parish was also able to ease some of the financial strain that was felt more acutely by other parishes in the Archdiocese. We would like to thank our parishioners for your active engagement that makes this possible.

Highlights of our financial results are as follows. Operating income for Fiscal Year 2023 was just under \$6 million, plus other income of \$1.9 million received from Archdiocese Second Collections, bequests, Annual Catholic Appeal rebate, sale of real estate, capital collections and restricted donations for total income of \$7.9 million. Operating expenses were approximately \$5.5 million, with other expenses of \$1.5 including Archdiocese Second Collections and Capital Improvement expenses for total expenses of \$7 million. Net income finished the year at \$783,000, a figure that was above our projected budget. Thanks to your generosity, collections from Sunday Mass and Holy Days came in \$85,000 over budget.

Last year the parish invested \$1.2 million in capital expenditures. Projects included Primary Grade Center roof replacement, Baptismal Font Enlargement, Upper Grade Center carpet replacement and parish wide network infrastructure upgrades. You will also notice significant investments in our fire, safety and security system infrastructure, in addition to HVAC improvements.

In terms of education, our school and parish ministries continue to offer inspirational direction and encouragement to children and adults on their lifelong journeys through faith formation. Healthy enrollment figures and tuition adjustments have created solid financial footing for the School of St Mary. Income approaching \$4 million produced a modest surplus of \$40,000. The school exceeded enrollment budget of 415 students with an actual enrollment of 431 students. Current enrollment is 434 Crusaders once again exceeding budget by 19 students. Operating a Blue Ribbon school requires significant expenditures. We aim to keep tuition moderate to attract families to Catholic education. We are grateful for the continued support of the Parents Association, which helps to bridge the gap between operating costs and tuition.

Our Religious Education program continues to provide an inspiring learning experience as well. Last year's enrollment exceeded budget by 21 students with 327 students enrolled from kindergarten through eight grade. Current enrollment stands at 319 which is 13 students above budget. In thanksgiving for a wonderful year of growing in faith the Religious Education Ministry continued to find opportunities for families to engage together in prayer, learn about our faith, and grow together in love for God. Our program welcomed new families and saw an increase in participation of children and volunteers.

While it appears at first glance that our resources are abundant, our anticipated capital requirements will warrant significant investment in the coming years. Aging buildings at an active parish require vigilant monitoring and investment. The goal of the Parish Finance Council is to address small issues before they become costly emergencies. We've begun turning our attention to several new items fitting that description. You've probably noticed the skeletal breezeway at the Upper Grade Center. The area is secure for students, staff and visitors to travel beneath in this interim period, but practical safety considerations point to Summer 2024 before construction can be completed. Both campuses may require interior upgrades that individually are not major expenses but cumulatively could have a notable impact on our financial position.

In closing, the Council kindly urges parishioners to remember St. Mary's in their estate planning considerations, and to make use of GiveCentral for making other recurring donations. We would like to reemphasize our gratitude for the financial blessings at the disposal of our parish. The parish is on a sound financial operating level and has the people and the resources to meet our needs as they arise in the near future.







## Financial Statements Footnotes

#### THE ARCHDIOCESE OF CHICAGO & PARISH OF ST. MARY ACCOUNTING POLICIES

The Church of St. Mary's financial statements are prepared on the modified cash basis, which is a comprehensive basis other than generally accepted accounting principles in the United States of America (US GAAP). Under the modified cash basis of accounting, adjustments to the cash basis accounts are made to conform to certain Archdiocesan provisions. Revenues and expenses are recognized only as cash received or paid, except as for certain modifications specified by the Archdiocese. Prepaid tuition is recognized as a liability in the statements of financial position - modified cash basis, and the Parish endowment funds are recorded at fair value as provided by the Archdiocese. In addition, the Archdiocesan provisions require real property of the Parish to be held in trust by the Archdiocese of Chicago. Other land and buildings, such as rental properties and the Primary Grade Center land, are carried at cost by the Parish and are not depreciated.

#### {1} Savings & Investments at Archdiocesan Bank

The Parish holds cash reserves in the Archdiocesan Bank in Certificates of Deposit earning interest for short-term and long-term capital maintenance and improvements.

#### {2} Investments & Endowment Funds

The Church of St. Mary holds two endowment funds both held in charter with the Archdiocesan Bank. The Parish Educational Endowment Fund is restricted for educational use only by the Parish. The Parish can draw on the accumulated earnings of the fund at any time to support the further education of children and adults alike through the Religious Education program, Evangelization, or the School. Changes in the balances are from pooled investment gains or losses and donations received by the Church and deposited into the fund.

The Parish Scholarship Endowment Fund corpus was donated from an anonymous donor in 2007 for the purpose of supporting families with financial need in attending the School of St. Mary. Per the charter, only 5% of accumulated earnings can be withdrawn from the fund annually.

The Parish transferred \$3 Million dollars in FY2022 from local savings of unrestricted funds into an Archdiocese of Chicago Growth Fund and Balanced Fund for the future use on capital expenditures.

#### **{3} Archdiocesan Assessments**

The Church of St. Mary paid three general assessments to the Chicago Archdiocese totaling \$241,898 in Fiscal Year 2023:

#### Archdiocese Assessment

The Archdiocese Assessment is billed at 10% of the Church's revenue from operations (less interest) from FY2021 reported closed financials. This assessment positively impacts the Parish with supporting functions such as: financial, operational, legal, insurance, risk management, human resources, payroll & benefits, religious education as well as pastoral and liturgical functions.

#### Office of Catholic Schools Assessment (OCS)

The Office of Catholic Schools Assessment (OCS) is billed at a fixed rate per student. The cost per student in FY2023 was \$36.00. The Office of Catholic Schools helps to support the School of St. Mary with services concerning human resources, legal, curriculum, instructional and educational needs.

#### Priest Retirement Mutual Aid Association Assessment (PRMAA)

The PRMAA Assessment supports the retirement fund for our priests within the Chicago Archdiocese. The amount billed by PRMAA is 3.5% of the total church operating revenue (less interest) of FY2021 reported closed financials.

#### {4} Annual Catholic Appeal

Church of St. Mary parishioners donated \$220,686 to the 2022 Annual Catholic Appeal of which St. Mary's received \$104,799 as a rebate.

#### **{5}** Estates & Bequests Donations

The Church of St. Mary received 5 monetary estate bequests in FY2023 totaling \$805,084 from generous parishioners who remembered St. Mary's in their estate planning.

#### **{6}** Capital, Restricted Donations and Related Expenses

Restricted donations received in the current year and prior years were released for the following:

- Fr. Barry Preservation Capital Fund
- · Church Baptismal Font

The Guild of St. Mary donated \$42,500 to the Church of St. Mary in FY2023.

#### **{7}** Sale of Property

The property located at 178 E. Illinois in Lake Forest was purchased by the parish in 1994 and sold in 2022. Proceeds are held in reserve for capital maintenance.




