

This Annual Financial Report of Fiscal Year 2021 began on July 1, 2020 and ended on June 30, 2021. In July of 2020 we were looking forward to "welcoming" worshippers back to Mass, with social distancing. In August of 2020, our school faculty and administration were looking forward to "welcoming" students into the classrooms, with all the proper safety protocols in place. In September 2020, our Religious Education program worked with parents and families in "welcoming" on-line formation for our families. It was a year filled with challenges and adjustments to our norms. It was a year filled with parishioners coming together, praying together, welcoming one another in a variety of ways.

The Parish Staff and parish leadership was very grateful for the people that came forth, helping out, volunteering and working tirelessly so we would be able to, with adjustments to established routines, come together and "welcome" one another during Covid-19.

Trusting in God, "welcoming God's grace anew" into our lives, we prayed, we served, we helped, we supported, we gave thanks.

As the previous fiscal year ended, the SBA PPP (Small Business Administration Paycheck Protection Program) loan helped us get through a challenging time for the parish. During this past fiscal year, the forgiveness of the loan puts us in a very favorable financial position for the Church of St. Mary, our School and Religious Education programs and all other ministries. We anticipate that with the continued faithful reflection and support of parishioners in this new fiscal year, building on last year, we will continue to be able to "welcome one another as the Lord has welcomed us": into church, into school, into religious faith formation and living the sacraments with joy and hope.

Thank you for your contributions, your sacrifices your prayers this past year, this COVID year, and this year of God's guiding grace.

On behalf of the entire parish, with the guidance and support of the Parish Council and Parish Finance Council, I trust that the future will provide all of us many opportunities to welcome one another in Christ Jesus.

# All Are Welcome, from the Finance Council

The Parish Finance Council is pleased to present the Annual Financial Report for the period ending June 30, 2021. The Church of St. Mary has navigated another year of challenge and uncertainty and is in excellent financial position. First and foremost, we have you, our parishioners, to thank for our good fortune. Your generosity and support have ensured that our parish remains vibrant, our Blue Ribbon school continues to educate our children at a high level, and we are able to serve our parish ministries and those in need throughout our community. The Parish Finance Council remains focused on serving and advising our Pastor, Fr. Nacius, as he leads our parish forward.

The generosity and support of our parishioners is the primary reason for our strong financial position. Other factors contributing to this strength include the ongoing positive impact of the PPP loan of \$766K, which was critical in supporting our teachers and staff during the depths of the Covid crisis; positive returns within our school's endowment funds of 32.6% and growth of \$588K; meaningful increases in enrollment in both our School and Religious Education program; and strong expense management throughout the pandemic. This was offset by a decrease in church donations of 7% from the prior year, although we did see an increase in online giving through Give Central. Therefore, we ended the 2021 fiscal year with net operating income of \$768K compared to a net loss of \$151K in fiscal 2020.


Prior to the Covid-19 health crisis, our school's enrollment was struggling, falling to a low of 350 students in 2019. We now have 430 students enrolled and expect this growth to continue under the leadership of our new principal, Dr. Julie Brua. In-person learning throughout the pandemic and continuing investment in our curriculum allows us to realize our school's mission statement: *To Learn. To Serve. To Lead.*

Additionally, we have seen steady growth in our Religious Education program. Current enrollment stands at 289 students a 17% increase from last year. This is a reflection of more families moving to our community and joining our parish. The growth and expansion of our parish family and our community of faith is deeply positive for the health and vibrancy of the Church of St. Mary.

The Parish Finance Council remains ever vigilant to the challenges that lie ahead. Maintaining our facilities and investing in the necessary capital projects is a top priority. We remain focused on ensuring the parish is financially prepared for these projects today and well into the future. In the last year, we improved the landscaping in the area around the entrance of the Upper Grade Center School and have just completed a masonry restoration and tuck-pointing project around the church. Looking forward, there are other significant capital projects that will require funds over the next five years and beyond to ensure proper maintenance of our facilities (refer to the chart).

We are blessed to find our parish is in a healthy financial position and are continuously grateful for the strong support of all those in the parish community. We encourage parishioners to continue and/or begin to use Give Central for online giving and to prayerfully consider future opportunities to share their time, talent and treasure within our parish community. We, as the Parish Finance Council, will continue to work with Fr. Nacius to prudently manage the financial resources of our parish to ensure that our church, school and neighboring parish community continue to flourish.

# Financial Statements Footnotes

## THE ARCHDIOCESE OF CHICAGO & PARISH OF ST. MARY ACCOUNTING POLICIES

The Church of St. Mary's financial statements are prepared on the modified cash basis, which is a comprehensive basis other than generally accepted accounting principles in the United States of America (US GAAP). Under the modified cash basis of accounting, adjustments to the cash basis accounts are made to conform to certain Archdiocesan provisions. Revenues and expenses are recognized only as cash received or paid, except as for certain modifications specified by the Archdiocese. Prepaid tuition is recognized as a liability in the statements of financial position - modified cash basis, and the Parish endowment funds are recorded at fair value as provided by the Archdiocese. In addition, the Archdiocesan provisions require real property of the Parish to be held in trust by the Archdiocese of Chicago. Other land and buildings, such as rental properties and the Primary Grade Center land, are carried at cost by the Parish and are not depreciated.

### {1} Savings & Investments at Archdiocesan Bank

The Parish holds cash reserves in the Archdiocesan Bank in Certificates of Deposit earning interest for short-term and long-term capital maintenance and improvements.

### {2} Investments & Endowment Funds

The Church of St. Mary holds two endowment funds both held in charter with the Archdiocesan Bank. The Parish Educational Endowment Fund is restricted for educational use only by the Parish. The Parish can draw on the accumulated earnings of the fund at any time to support the further education of children and adults alike through the Religious Education program, Evangelization, or the School. Changes in the balances are from pooled investment gains or losses and donations received by the Church and deposited into the fund.

The Parish Scholarship Endowment Fund corpus was donated from an anonymous donor in 2007 for the purpose of supporting families with financial need in attending the School of St. Mary. Per the charter, only 5% of accumulated earnings can be withdrawn from the fund annually.

### {3} SBA PPP Loan Forgiveness (Small Business Administration Paycheck Protection Program)

In FY2020, the Parish applied for and received an SBA PPP loan of \$765,870, as a result of the SBA COVID-19 stimulus package. The loan was forgiven and recognized as "other income" in FY2021.

### {4} Archdiocesan Assessments

The Church of St. Mary pays three assessments to the Chicago Archdiocese annually totaling \$266,568 in Fiscal Year 2021:

#### *Archdiocese Assessment*

The Archdiocese Assessment is billed at 10% of the Church's revenue from operations (less interest) from FY2019 reported closed financials. This assessment positively impacts the Parish of St. Mary with supporting functions such as: financial, operational, legal, insurance, risk management, human resources, payroll, employee benefits, religious education as well as pastoral and liturgical functions.

#### *Office of Catholic Schools Assessment (OCS)*

The Office of Catholic Schools Assessment (OCS) is billed at a fixed rate per student. The cost per student in FY2021 was \$31.00. The Office of Catholic Schools helps to support the School of St. Mary with services concerning human resources, legal, curriculum, instructional and educational needs.

#### *Priest Retirement Mutual Aid Association Assessment (PRMAA)*

The PRMAA Assessment supports the retirement fund for our priests within the Chicago Archdiocese. The amount billed by PRMAA is 3.5% of the total church operating revenue (less interest) of FY2020 reported closed financials.

### {5} Annual Catholic Appeal

279 Church of St. Mary parishioners donated \$244,379 to the 2020 Annual Catholic Appeal of which St. Mary's received \$118,599 as a rebate.

- The Parish awarded \$33,681 in need-based financial aid in FY2021 to 11 students.







New School Primary Grade Center iPads
