## From the Desk of the Pastor

This Annual Report is a reflection of the goodness and generosity of the parishioners of St. Mary during the fiscal-year 2020 for period July 1, 2019—June 30, 2020. When the fiscal year started we were filled with hope, optimism and appreciation for all of God's blessings in our lives. In the third quarter of the fiscal year, the pandemic in the world required that we close the church and school buildings on March 13, 2020, while at the same time reaching out to parishioners, educating our children and trusting in God perhaps more fully and completely then we ever had.

An article was shared with parishioners at the onset of the pandemic reminding people to focus on four important deeds. These four actions or behaviors are:

- 1) Pray. Do not ever abandon a life of prayer, especially in trying times.
- 2) Reach out to your neighbors. Call your neighbors and check in on them.
- 3) Spend time with your family. Reconnect and focus on those relationships that are present in your life.
- 4) Entrust all of this to Christ. Look to Christ and know He is with you; you are not alone.

I pray that having reviewed this entire Annual Report that you would offer a prayer of thanksgiving to God for what we have been able to accomplish last year. As a believing people we will continue to grow in God's grace by committing and contributing our time, talent and treasure at our parish.

I give thanks for the gift of faith, the power of grace and the presence of the Spirit modeled by parishioners, in their lives, family, community, Church and world. May all who participate in the Church of St. Mary continue to grow in faith and compassionate care for our neighbor. We worship, coming together in thanksgiving, so that we can be sent forth into the world as the hands, feet, and heart of Christ to one another.

### From the Parish Finance Council

Thank yoy

Dear Parishioners of the Church of St Mary,

The Church of St. Mary Parish Finance Council wishes to thank all parishioners for their continued and generous support of the Church of St. Mary. Your financial stewardship helps fund the ministries of the Parish, our Religious Education programs and our school. To say the least, this has been a most unusual year that started with such promise for all of us but was interrupted by the pandemic. As Fr. Nacius informed us in his letter, the pandemic has profoundly affected all our lives and has created significant challenges for the ongoing ministry at our Parish.

The Church relies on revenue from the faithful generosity of parishioner donations in the offertory collection at Mass and electronically. The School and Religious Education program receives three sources of revenue; tuition and fees, fundraising and donations and our Parish subsidy. The following is a summary of our financial results for the fiscal year ending June 30, 2020.

Revenue from Operations, which includes offertory collections, tuition and fees, was \$4.673 million, and ended unfavorably from budget. Expenses of \$4.823 million ended favorably versus budget. Lower expenses were a result of shelter-in-place mandates and fiscally responsible management or elimination of expenses during church and school building closures. An unfavorable decrease in donations and a favorable decrease in expenses resulted in a Net Operating Loss of the Parish of (\$150,800) for fiscal-year ending June 30, 2020.

The Fiscal 2020 Budget included a projected School subsidy of \$690,000. This subsidy is funded from three sources: \$280,000 from Church operations, \$200,000 from the Parish Education Endowment Fund and \$210,000 from School Parents' Association. Lower school enrollment and efforts to keep school tuition as low as possible necessitate these additional sources of funding for the School. The Budget also included \$78,354 Religious Education subsidy funded from Church operations.

In the fourth quarter of FY20, the Parish applied for and received a loan from the Paycheck Protection Program (PPP) in the amount of \$765,870. As a result of receiving the PPP Loan, the Parish was able to defer the Religious Education and School subsidies as well as the School Parents' Association donation for use in Fiscal Year 2021. The Parish has applied for, and expects to receive, forgiveness for the PPP loan from the Small Business Administration.

Other Income includes donations which are earmarked for our sharing parish, Most Blessed Trinity, and Archdiocese Second Collections. These funds are remitted in the current year to Most Blessed Trinity and the Archdiocese. Additional donations with restrictions include donations for the Fr. Barry Capital Fund, the To Teach Who Christ Is Campaign, and School Staff Bonuses.

Restricted donations from current and prior years were used in FY20 including capital expenditures from the Fr. Barry Capital Fund, the St. George Financial Need-Based charitable fund, the Fr. Madden scholarship fund, and School Staff Bonuses.

Fiscal Year 2020 was a significant year for capital expenditures. The Parish invested over \$1 Million dollars in a variety of projects to repair, improve, address safety concerns, and beautify various parts of our aging facilities. These include the Church East Stairs Improvement project, restoration of the Church organ, new Church vestibule cabinetry, replacement and upgrade of the Church Fire Detection system, upgrade of the Church Sound System, Rectory kitchen remodel, and various School building and grounds repairs and upgrades. Net Other Income (Expense) ended at a loss of (\$691,858) for fiscal-year ending June 30, 2020. All projects were planned, approved and funded by current and prior year donations. Capital planning in previous fiscal years placed donations in certificates of deposit for future capital projects. The above mentioned projects were fully funded by the generosity of the parishioners of the Church of St. Mary.

The Parish Finance Council anticipates, due to the continued support of current and future parishioners, the ability to maintain and expand our outreach and ministry to the larger world. The COVID realities in the fall of 2020 require all of us to relook at our resources and charitable contributions. Thank you for making the Church of St. Mary one of yours and your family's priorities last year as well as going forward.

2020 has been an extraordinary and historic year. We are blessed to have been able to support the staff, administration, and faculty through the PPP program, but this has only deferred the short-term issues and long-term challenges that face St. Mary's. Ultimately, our parish's path to a sustainable budget relies on the generosity of all parishioners. Weekly giving through the pandemic is down over 25%. Our Blue Ribbon School and Religious Education program has the capacity for many more students. We need not just your financial support, but your engagement and participation in our parish community. This will ensure not only our successful navigation of these current times, but that St. Mary will thrive for generations to come.

Know that you can reach out to any of the members of the Parish Finance Council if you have questions. May your celebrations with family of Thanksgiving and Christmas be healthy and joyous for all.



## Financial Statements Footnotes

#### THE ARCHDIOCESE OF CHICAGO & PARISH OF ST. MARY ACCOUNTING POLICIES

The Church of St. Mary's financial statements are prepared on the modified cash basis, which is a comprehensive basis other than generally accepted accounting principles in the United States of America (US GAAP). Under the modified cash basis of accounting, adjustments to the cash basis accounts are made to conform to certain Archdiocesan provisions. Revenues and expenses are recognized only as cash received or paid, except as for certain modifications specified by the Archdiocese. Prepaid tuition is recognized as a liability in the statements of financial position - modified cash basis, and the Parish endowment funds are recorded at fair value as provided by the Archdiocese. In addition, the Archdiocesan provisions require real property of the Parish to be held in trust by the Archdiocese of Chicago. Other land and buildings, such as rental properties and the Primary Grade Center land, are carried at cost by the Parish and are not depreciated.

#### {1} Savings & Investments at Archdiocesan Bank

The Parish holds cash reserves in the Archdiocesan Bank in Certificates of Deposit earning interest for short-term and long-term capital maintenance and improvements.

#### **{2}** Investments & Endowment Funds

The Church of St. Mary holds two endowment funds both held in charter with the Archdiocesan Bank. The Parish Educational Endowment Fund is restricted for educational use only by the Parish. The Parish can draw on the accumulated earnings of the fund at any time to support the further education of children and adults alike through the Religious Education program, Evangelization, or the School. Changes in the balances are from pooled Investment gains or losses and donations received by the Church and deposited into

The Parish Scholarship Endowment Fund corpus was donated from an anonymous donor in 2007 for the purpose of supporting families with financial need in attending the School of St. Mary. Per the charter, only 5% of accumulated earnings can be withdrawn from the fund annually.

#### **{3} Oakwood Rental Property**

The property located at 494 Oakwood was purchased by the parish in 1992 and sold in 2019. Proceeds from the rental property are held in reserve for capital maintenance.

#### {4} SBA PPP Loan (Small Business Administration Paycheck Office of Catholic Schools Assessment (OCS) **Protection Program**)

The parish applied and received the SBA PPP loan as a result of the SBA COVID-19 pandemic stimulus package, of which is expected to be forgiven.

#### **{7}** School of St. Mary Tuition & Financial Aid

- \$49,625 was received as tuition subsidy from St. Patrick's Church for 24 students that were parishioners of St. Patrick's who attended the School of St. Mary in
- \$4,050 was received as tuition subsidy from Holy Cross Church for 2 students that were parishioners of Holy Cross who attended the School of St. Mary in FY2020.
- The Parish awarded \$47,324 in need-based financial aid in FY2020 to 15 students.
- \$29,454 was received from the Illinois Tax Credit Scholarship Program awarding financial aid to 5 students.

#### **{8}** Archdiocesan Assessments

The Church of St. Mary pays four assessments to the Chicago Archdiocese annually:

#### Archdiocese Assessment

The Archdiocese Assessment is billed at 10% of the Church's revenue from operations (less interest) from FY2018 reported closed financials. This assessment positively impacts the Parish of St. Mary with supporting functions such as: financial, operational, legal, insurance, risk management, human resources, payroll, employee benefits, religious education as well as pastoral and liturgical functions.

The Office of Catholic Schools Assessment (OCS) is billed at a rate per student. The cost per student in FY2020 was \$25.00. The Office of Catholic Schools helps to support the School of St. Mary with services concerning human resources, legal, curriculum, instructional and educational needs.

#### Lease & License Assessment

The Archdiocese Lease & License Assessment is billed at 10% of lease revenue received by the Parish from residential home rental leases and room leases.

Priest Retirement Mutual Aid Association Assessment (PRMAA) The PRMAA Assessment supports the retirement fund for our priests within the Chicago Archdiocese. The amount billed by PRMAA is 3.5% of the total church operating revenue (less interest) of FY2019 reported closed financials.

#### **{9}** To Teach Who Christ Is


\$30,638 of TTWCI donations were received in FY2020 and \$392,396 from current and prior year donations was expensed on the Church East Stairs & Plaza Improvement project.

#### **{10}** Annual Catholic Appeal

The Church of St. Mary parishioners donated \$262,044 to the 2019 Annual Catholic Appeal of which St. Mary's received \$154,272 as a rebate.

### Church Organ Restoration

We received an anonymous donation from a family as part of "Phase Four and More" program at St. Mary which fully supported the 1981 Moller pipe organ restoration. Among the work that was completed, the organ console was upgraded to a modern processor based control system (replacing a pneumatic system which was wearing out), that enabled the addition of a record-playback function, multiple banks of piston memory, transposer and MIDI capability.


